Dear President Donald J. Trump,

In the decree I issued with effect from September 1, 2020, both your nation and all other nations included in the enemy list of the United Nations were prohibited from operating a non-governmental organization in violation of international law on the territory of the occupied German Reich, with the name Federal Republic of Germany, or United Economic Area or GDR or Germany. Also, a compensation for damages in the amount of 1 million USD per day for violation of this decree was determined.

We had to find out that you, as well as all other responsible persons of the other nations disregarded this decree.

For this reason, we feel compelled to hand over to you, as the declared overall winner, in accordance with the 1944 London Agreement, the first of the invoices for damages due after 7 days. In order to secure the claims of the German Reich, the invoices will be registered and published in the UCC according to the rules you have set up yourself.
